On behalf of the executive committee and all the membership of the BBA, I'd like to thank Cathy Reade for the immense and professional support that she has provided to our association for the last 8 years.

I hope that the move to London with the support of the Healing Foundation team will further our progress in the years to come. Our immediate task is to establish strong governance and maintain financial stability. The new website will play a major role in communications as in, for example, the day to day running of the EMSB and also for the annual conference.

As we discussed at the AGM, the BBA committees have been expanded from two committees, Education and Prevention, to four. The four committees will work in tandem with the 3 subgroups of the National Network of Burn Care (NNBC). These committees / Subgroups are listed alongside. I am delighted that the partnership of

the BBA and the prestigious Society of Academic & Research Surgery (SARS), has been now been formalised.

The BBA session at the annual SARS meeting is scheduled to be held on Thursday 6th January 2011 in Dublin. Please submit abstracts directly to the BBA offices, not to the SARS website. The closing date is 30th October 2010.

This year the Healing Foundation will start the process of offering up to three, five year 'programme grants' to promote education and research in UK and Ireland. The application packs will be distributed to all interested parties shortly. The total grant for these centres is £1.5m.

It has been an exciting few months and the executive committee is looking forward to our next annual conference in Salisbury (22nd – 25th March 2011). The local organising team led by Mr Eunan Tiernan has been already working hard to make the 44th annual conference a memorable experience.

UK Burns Research Centres—awards available

The Healing Foundation has begun the process of establishing up to three centres of Burns Research in the UK & Ireland, by publishing an application pack on the Foundation's website. Each award is worth up to £1.5 million over five years and the closing date has been set for 16 December 2010. Already, 16 Universities throughout the UK and Ireland have expressed interest in bidding for the funds.

Following review and selection, a decision is likely to be announced in early summer 2011.
